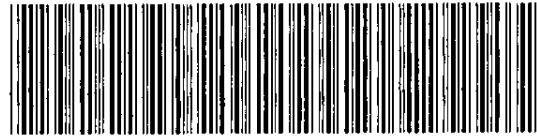

ARTICLE I NAME:

ARTICLE III PURPOSE(S)

The objectives and purposes for which this Church Corporation is constituted and organized are:

- The purposes for which the Corporation is organized are exclusively religious, charitable, and educational with the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law.
- To conduct a local church by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in accordance with all the commandments and provisions as set forth in the Holy Bible, the irrevocable Word of God Pursuant thereto, the following activities and guidelines shall be established
