Article 1-Name

Higher Heights Inc. shall be a nonprofit organization incorporated under the laws of the State of Florida.

Article II-Registered Office Address/ Principle Office Address

Article III-Purpose

Higher Heights Inc. is organized exclusively for charitable and educational purposes.

The purposes of this corporation are:

- Counseling individuals and families in crisis, educating families by providing life skills, health issues, and nutritional courses.
- Prevent prison recidivism of youth offenders and prevent gang activity through support services and substance abuse education/prevention/rehabilitation.
- Economic empowerment

Article IV-Exemption Requirements

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

1. No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof.

2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

3. Notwithstanding any other provisions of this document, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax, under Section 501(c) (3) of the Internal Revenue Code or corresponding section of any future tax code, or by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future tax code.

Article V-Membership/Board of Directors

This corporation has no members.

The management of the affairs of the corporation shall be vested in a board of directors, as defined by the corporation's bylaws, No director shall have any right, title or interest in or to any property of the corporation.


