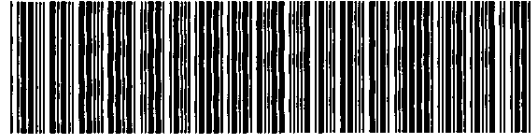

## ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (Not for Profit)

### ARTICLE I

#### NAME

The name of the corporation shall be:

### ARTICLE II

#### PRINCIPAL OFFICE

### ARTICLE III

#### PURPOSE

The Corporation is organized and shall be operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the United States Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States internal revenue law) (the "Code") and for such related purposes as may be permitted to charitable and educational corporations. The corporation, in order to implement these purposes, shall provide support, education, and social development to young girls who are currently being raised in single parent homes, where the father is the primary provider. These purposes shall be broadly interpreted to allow the corporation flexibility in engaging in all activities that promote the interests of the corporation, so long as the same do not adversely affect the corporation's tax-exempt status for federal income tax purposes. The corporation may engage in fundraising activities to fund its operations and for other charitable purposes. No part of the earnings, if any, of the corporation shall inure to the benefit of any private shareholder, member, or individual, and no substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, except when permitted by the Internal Revenue Code.

### ARTICLE IV

#### MANNER OF ELECTION

The manner of election of Board members and their terms, along with the requirements of Board membership, shall be set forth in the bylaws of the corporation.
