



## AMENDED AND RESTATED ARTICLES OF INCORPORATION FOR THORNTON PARK NEIGHBORHOOD ASSOCIATION, INC.

The undersigned, a majority of whom are either US citizens or permanent residents, desiring to form a Non-Profit, Tax-exempt Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

First: The name of the Corporation is THORNTON PARK NEIGHBORHOOD ASSOCIATION, INC.

**Second**: The place in this state where the principal office of the Corporation is to be located is 17 James Avenue, Orlando, FL 32801. The Corporation mailing address is the same.

Third: Members shall be entitled to vote.

**Fourth**: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Fifth**: The names and addresses of the persons who are the initial officers of the corporation are as follows:

Avery L. Hunt, Jr. (President), 914 E. Washington St, Orlando, FL 32801 Terrence E. Driscoll (Vice President), 22 N. Mills Ave, Orlando, FL 32801 Jan T. Schwartz (Secretary), 24 N. Thornton Ave, Orlando, FL 32801 John F. Moore (Treasurer), 17 James Ave, Orlando, FL 32801

The names and addresses of the person who are the current officers of the corporation are as follows:

Avery L. Hunt, Jr. (President), 914 E. Washington St, Orlando, FL 32801 David Desforges (Vice President), 914 E. Washington St, Orlando, FL 32801 Wayne Johnson (Secretary), 914 E. Washington St, Orlando, FL 32801 John F. Moore (Treasurer), 17 James Ave, Orlando, FL 32801

**Sixth**: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third above.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not:

- (a) shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or
- (b) shall not carry on any other activities not permitted to be carried on by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- (c) engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- (d) retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- (e) make any investments in a manner as to subject it to tax under section 4944 of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- (f) make any taxable expenditures as defined in section 4945 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

The corporation shall distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Seventh: Since the corporation is a non-profit, there are no shares for the Corporation.

Eighth: The initial registered agent for the corporation shall be as follows:

The current registered agent for the corporation shall be as follows:

John F. Moore 17 James Ave Orlando, FL 32801

Ninth: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal

government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.

Tenth: The method of election for the directors shall be provided for in the THORNTON PARK NEIGHBORHOOD ASSOCIATION, INC, corporate bylaws.

**Eleventh:** This Amendment and Restatement was approved and ratified by the Members and Directors of the Corporation at the Annual Meeting of the Directors dated January 10, 2023.
