ARTICLES OF INCORPORATION
For

Article I

CHOSEN VESSELS OF JESUS CHRIST MINISTRIES, INC.

Article II

The corporation is organized pursuant to the Florida Nonprofit Corporation Code for the following purposes:

- conduct conferences, teaching seminars and Bible studies in the continental United States and overseas;
- conduct revivals and/or crusades;
- own and operate shelters and group homes for the disadvantaged;
- operate television and/or radio ministry;
- own and operate transportation vehicle;
- own and operate family distribution which houses a food bank and clothing center;
- own and operate facilities to house various programs;
- sponsor day care and elderly programs;
- own and operate beauty salon, spa, gym and weight loss center;
- own and operate an employment assistance and financial guidance center;
- counsel adults and children;
- produce items for fund-raising; and
- to engage in any lawful business or activities related thereto; and to engage in any lawful act or activity for which nonprofit corporations may be organized under the state of Florida code.

Article III

Chosen Vessels of Jesus Christ Ministries is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purpose, the making of distributions to organizations that qualify as exempt organization under section 501© (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article IV

Upon the dissolution of Chosen Vessels of Jesus Christ Ministries, assets shall be distributed for one or more exempt purposes within the meaning section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
