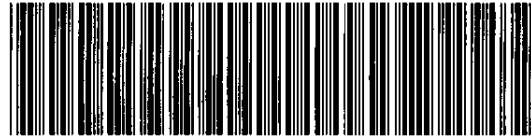

ARTICLE I NAME

God's Anointed Prayer Ministries International **INC.**

ARTICLE II PRINCIPAL OFFICE

11334 Rapallo Lane Windermere, Fl 34786

ARTICLE III PURPOSE

The Corporation is organized for the charitable and educational purposes that qualify under section 501 (c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTION

The manner in which the Directors are elected or appointed.

The Board shall consist of not less than three (3) directors as directed by law of the incorporating state, Florida. Directors can serve a maximum of three two year terms. Vacancies existing by reason of resignation, death, incapacity or removal before the expiration of his/her term shall be filled by a majority vote of the remaining directors. In the event of a tie vote, the President shall choose the succeeding director. Board will elect their directors. Potential candidates for Board of Directors must be nominated by a member of the Board or Staff. The nomination must be submitted in writing or electronically to the Nominating Committee. A director elected to fill a vacancy shall be elected for the unexpired term of that director's predecessor in office.




