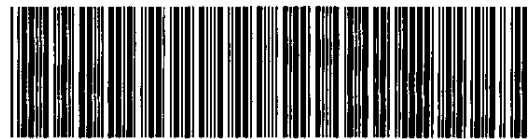

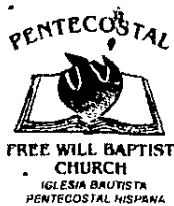

ARTICLES OF INCORPORATION

FOR THE:

The undersigned, acting as incorporators of a non-for-profit corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE 1: NAME

The name of the corporation shall be:

ARTICLE III: PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

ARTICLE IV: AFFILIATION

This Church Works in collaboration and in affiliation with:

Pentecostal Free Will Baptist Church, Inc.

With Headquarters at Dunn, North Carolina, USA

ARTICLE V: PURPOSES

The specific purpose for which the corporation is organized is to function as a non-for-profit organization, particularly as a church or ministry. Other functions or purposes are:

1. To proclaim the Gospel of Jesus Christ as the true alternative for salvation and true freedom for the soul, the mind and the spirit.
2. To provide religious and educational services through: World and Local Missions, evangelism, family or cell-groups religious education, support groups, etc.
3. To provide community services such as: food and clothing banks for the poor and the homeless, etc. as means becomes available.
4. To provide religious help services to benefit the membership and the community at large.
5. To provide healthy spiritual and social activities, such as: Youth programs, Senior citizens, family retreats, couples retreats, etc.
6. To participate in local and international relief efforts when means becomes available.
7. To conduct ministry through diverse areas of ministry: children, youth, men, women, singles, single parents, etc.
8. The equipping and training of Christian men and women for leadership and ministry through available means.
9. To assist in church planting effort in cooperation with our parent organization, the Pentecostal Free Will Baptist Church, Inc.

ARTICLE VI: MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

The Pastor/Chair and Incorporators have the power to appoint non-elected local church officers, with such power vested on the Chair to confirm or reject elected or non-elected officers. The directors or officers, except the Chair/Senior Pastor, are elected by the vote of the congregation as established by the constitution and by-laws. Elders and/or Trustees are appointed by the Chair and confirmed by the vote of the congregation. Deacons are voted by the majority of the vote of the Congregation.

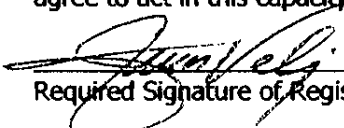
