ARTICLES OF INCORPORATION

OF

Body Of Christ International Fellowship Of Believers Inc.

ARTICLE 1 - NAME

The name of the corporation shall be: Body Of Christ International Fellowship Of Believers Inc

ARTICLE 2 - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 14916 Wildflower Lane Delray Beach, Florida 33446

ARTICLE 3 - DURATION

.The duration of the Corporation shall be perpetual

ARTICLE 4 - REGISTERED OFFICE & AGENT

The initial registered office of the corporation is 14916 Wildflower Lane Delray Beach, Florida and the initial registered agent at such address is Leroy York

ARTICLE 5 - PURPOSE

<u>Section 1. Principal Purpose.</u> The principal purpose of the Corporation shall be to operate a Christian Organization, exclusively for religious, charitable, scientific, literary, or educational purpose, as those terms are defined by Section 501(c) (3) of the internal Revenue Code of 1954.

Section 2. Limitations. The Corporation shall have no capital stock, and no part of its net earnings shall inure to the benefit of any trustee, officer, or member of the corporation, or any private individual.

No member, trustee or officer of the corporation, nor any private individual shall be entitled to share in the distribution of any of the corporate assets upon dissolution of the Corporation, or the winding up of its affairs. Upon such dissolution or winding up, all the remaining assets of the corporation shall be distributed by the Board of Trustees for identical uses and or purposes to any other organization which would then qualify for the exemption under the provisions of Section 501 (c) (3) of the internal revenue Code as now stated, or as it may be hereafter amended.

No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting, to influence legislation except as may be permitted to Section 501 (c) (3) organizations by the Internal Revenue code, and the corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

. <u>Section 3. Powers.</u> In general, and subject to such limitations and conditions as are or may be prescribed by the law, or in the Corporation's Articles of Incorporation or Bylaws, the Corporation shall have all powers which now or are hereafter conferred by law upon a corporation organized for the purposes herein above set forth, or necessary or incidental to the powers so conferred, or conductive to the attainment of purpose of the Corporation.

ARTICAL 6 - MANAGEMENT

Section 1. The Management of the Corporation will be vested in a board of no less than five (5) directors, the number, qualifications, terms of office, manner of election, time and place of meeting, and powers and duties of the Trustees shall be such as are prescribed by the Bylaws of the Corporation.

The authority to make amend or repeal Bylaws is vested in the Board of Directors, and may be exercised at any regular or special meeting of the board.

Article 8- Dissolution

Section 8.1 A resolution to dissolve the church must include provision for the distribution of remaining assets to a designated nonprofit fund, foundation or corporation which is organized and operated exclusively for religious purpose and which has established its tax exempt status under Section 501 (c) (3), Internal Revenue Code.
