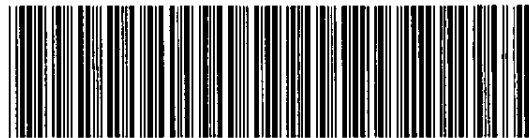

**NEW CORPORATE NAME:**

The name of the corporation is changed from LAKELAND AERO CLUB, INC. to **DRANE FIELD AVIATION, INC.**, and ARTICLE I of the Articles of Incorporation of the corporation shall be amended to read as follows:

**ARTICLE I  
NAME**

The name of this corporation is **DRANE FIELD AVIATION, INC.**

**DATE OF ADOPTION OF AMENDMENT AND EFFECTIVE DATE:**

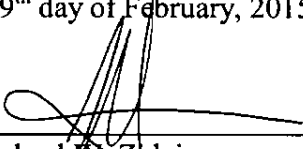
The date of the adoption of the amendment was February 9, 2015.
