ARTICLE III

PURPOSE

- c) To bring awareness to our local community and communities across the nation, educating them about various social injustices.
- d) To organize centers where workers may carry out the above purposes.
- e) To put together special events and venues to carry out the above purposes.
- f) To contract, buy, sell, lease or rent property, real, personal, or mixed for nonprofitable purposes.
- g) To mortgage and incur liability on behalf of the incorporation and to employ help.
- h) To work and exist not only in Florida but universally and world wide.
- i) To use funds toward any charitable cause at the discretion of the governing board of directors.
- j) To do and perform all other things generally which are necessary or become desirable to promote and encourage the above purposes and lead others to a fuller knowledge of Jesus Christ in the world today.

k) The purposes for which this corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

l) In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purposes.
