ARTICLES OF INCORPORATION

Fondation Anne-Marie Morisset, Inc

Article VIII: Required Purpose Clause

This corporation is organized and operated exclusively for charitable, educational, scientific, literary and amateur sports competition purposes within the meaning of 501(c)(3) of the Internal Revenue Code.

Article IX: Dissolution of Assets Provision

Upon dissolution, any assets of the corporation must be distributed to one or more organizations of like practice recognized by the Internal Revenue Service as one organized exclusively for charitable, scientific, literary, or educational purposes.
