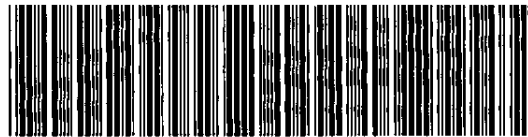

ARTICLES OF INCORPORATION OF THE ST AUGUSTINE REGIONAL COUNCIL, INC

The undersigned, as incorporators, all of whom are citizens of the United States of America, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Laws of the State of FL, adopt the following Articles of Incorporation, and do hereby certify:

ARTICLE I

The name of the Corporation shall be "St Augustine Regional Council, Inc."

ARTICLE II

The Corporation shall be of perpetual duration unless dissolved by law.

ARTICLE III

This Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(6) of the Internal Revenue Code, or the corresponding section of any future federal code.

The Corporation is formed to meet the substantial requirements in the community and state of persons who promote the community of St Augustine and the regional area..

The Corporation reserves its right to exercise the powers provided for non-profit organizations in the State of Florida as set forth in section 617.0302, Florida Statutes, and any subsequent amendments thereto, including any and all things whether therein mentioned or not necessary or incidental to the carrying out of the purposes set forth herein. Such powers shall be construed liberally and shall not be construed as a limitation of the Corporation's ability, it being intended that the Corporation shall have all the rights, powers, privileges that any nonprofit organization would have. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(6).

ARTICLE IV

The method of election of the board of directors will be stated in the bylaws. This corporation is a membership organization.

ARTICLE IX

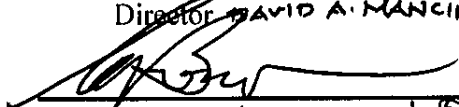

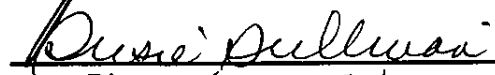

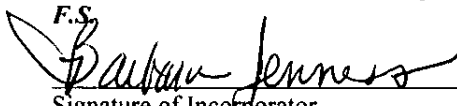
