**ARTICLE VIII
DISSOLUTION CLAUSE**

**ARTICLE IX
OTHER PROVISIONS**

No part of the net earnings of Patt Enterprises of Tampa, Inc. will benefit or be distributed to our directors, or their family members, trustees, or officers or other private persons, except Patt Enterprises of Tampa, Inc. shall be authorized or empowered to pay reasonable compensation for services rendered and to make payments and distributions, in furtherance of Section 501(c) 3 purposes. There will be absolutely no political activities of any kind carried on by Patt Enterprises of Tampa, Inc.

Notwithstanding any other provisions of these articles, Patt Enterprises of Tampa, Inc. will not carry on any other activities not to be carried on, as defined under Section 501(c) 3, of The Internal Revenue Code, or by a corporation, contributions to which are deductible under Section 170 (c) 2 of The Internal Revenue Code.
