

ADDITIONAL ARTICLES VIII AND IX

UNITED VETERANS ASSOCIATION, INC.

ARTICLE VIII — Distribution of Net Earnings: No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members trustees, officers, directors, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III of the corporations Articles of Incorporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future tax code.

ARTICLE IX - Dissolution of this Corporation: Upon the dissolution of the corporation, the assets shall be distributed for one or more exempt purposes within the meaning of sec. 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the main office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated solely for such purpose.
