## Purpose and History of Corporation

#### **History and Development**

Lets Go Ministry Inc is being incorporated in 2010. The ministry is an outreach including the ministers Jed Lindstrom and Erica Lindstrom that began in St. Paul MN in 2006. In the years 2006 through 2010 they worked in and through the ministry of Ripe for Harvest World Outreach/Mesa, AZ. Lets Go Ministry Inc. has been created as an outreach to America to share the gospel of Jesus Christ, the team of ministers believes that God has called them not only to evangelize but train and educate others to evangelize and minister the hurting in America. #### Form and Schedule of Service

## Form of Worship

Forms of worship depends on the type of service

- A) Our form of worship service includes singing, worship, announcements, and preaching with an opportunity for prayer at the end.
- B) Bible study services consist of 1 to 2 hour teaching and lectures on the Holy Bible.
- C) Revival and outreach services around America are held in churches, tents, and on the streets. Each one is organized and operated according to the leadership or denomination we are working with.
- D) Local ministry Lets Go Ministry Inc. works directly with a local church assisting in meetings, services, and outreach. At present we are working with The Sanctuary Fellowship Church in Daytona Beach, Florida.

#### **Purpose of Non Profit Corporation**

Lets Go Ministry Inc. was organized and formed for the purpose of Christian evangelism within the local community as well as throughout the United States and abroad. Our ministries include holding regular services, preaching and teaching the Gospel of Jesus Christ on the streets and in other churches, providing Christian counseling to people within the community with chemical dependency problems, and providing spiritual support and guidance for our youth. All of our efforts and activities are made for the sole purpose of glorifying God and communicating His message of salvation.

#### **Inurnment of Income**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to, its members, directors, officers or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered.

#### Legislative or Political Activities

No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the Corporation shall not participate in or intervene (including the publishing or distribution of statements) in any political campaign on behalf of any candidate for public office.

## **Operational Limitations**

Notwithstanding any other provisions of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law).

#### Article IV

#### **Directors**

Directors of Lets Go Ministry Inc. are appointed by the administration. The administration prays for and seeks counsel for recommendations of directors of the ministry. The administration sends a request letter to the potential director requesting them to pray and we receive a letter of commitment from the director to be on the board. Terms of directors are nonspecific but we require them to stay in relationship with the administration. At any such time that the administration feels the need to change directors they will first contact the director that they are looking to remove about the situation and seek counsel and the administration will receive a letter of resignation before appointing a new director.
