Article 3: Corporate Purpose: The Corporation is organized and shall be operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, including the including the making of distributions for such purposes to organizations that qualify as exempt under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law). These purposes include the following:

- (a) to sponsor, promote, and support programs that address the lack of medical and dental care in the United States and in under-developed countries;
- (b) to provide information to educate the general public and residents of underdeveloped countries on hygienic living conditions and safe shelter;
- (c) to asist medical and dental students and licensed physicians and dentists in providing health and dental care in those areas targeted by the Corporation's activities;
- (d) to assist other professionals and groups to provide educational, economic, environmental and other assistance to improve the living and health conditions of the general public and residents in underdeveloped countries in the areas targeted by the Corporation's activities;
- (e) to participate in activities designed and carried on to promote the general health of individuals in the communities served by the Corporation's activities:
- (f) to provide financial assistance to facilitate treatment;
- (g) to receive and administer funds for the benefit of the Corporation, or its successor, and to that end to take and hold, by bequest, devise, gift, purchase, or lease, either absolutely or in trust, any property, real, personal or mixed, without limitation as to amount or value, except such limitations, if any, as may be imposed by law.
