The undersigned incorporators of this corporation under the provision of Chapter 617 of the Florida Statute, as amended adopt the following Articles of Incorporation:

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from

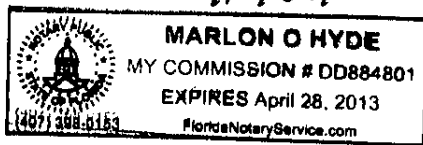
Article X: Dissolution of the corporation
