Pursuant to the provisions of section 617.1006 of the Florida Not-for-Profit Corporation Act, this Florida Not For Profit Corporation hereby adopts the following amendment to its Articles of Incorporation:

1. The name of the corporation is: ICCA MIAMI 2014, INC., (the "Corporation"). The date of filing the original Articles of Incorporation of the Corporation with the Florida Secretary of State was December 29, 2010, under document number N10000011923.

2. Article I of the Articles of Incorporation of the Corporation is hereby amended as follows:

"ARTICLE I. NAME
