The undersigned, all of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

ARTICLE I. NAME

Dolly's Foundation – Rescue, Educate, Advocate INC.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this corporation is 383 Old Geneva Road, Geneva, Florida 32732.

ARTICLE III. INITIAL REGISTERED AGENT

ARTICLE V. CORPORATE PURPOSE

The purpose of Dolly's Foundation is to rescue, rehabilitate and rehome homeless, neglected, and abused American Pit Bull Terriers and other bully breed dogs. As well as preserve, promote and bring positive awareness to the breed and the negative stereotype bestowed upon them.

ARTICLE VI. INITIAL TRUSTEES

ARTICLE VII. PROVISIONS

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that of this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof.

No substantial part of the activities of the corporation shall constitute the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provisions of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VII. DISSOLUTION

Upon the dissolution of this corporation, after all outstanding liabilities have been settled, all assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the Seminole County Animal Services of Seminole County, Florida.

ARTICLE IX. EFFECTIVE DATE

The effective date of this corporation's existence shall be January 1, 2011.
