Article III of the Association's Articles of Incorporation has been amended as follows:

ARTICLE III REGISTERED AGENT

John K. Renke III, whose address is 7637 Little Road, New Port Richey, Florida 34654, shall be the registered agent for the corporation.

Part f. of Article IV of the Association's Articles of Incorporation has been deleted.

The following sentence has been deleted from Article VIII of the Association's Articles of Incorporation: Only the officers of Secretary and Treasurer may both be held by one person.

The following sentence has been added to Article VIII of the Association's Articles of Incorporation: No person shall hold more than one office simultaneously.

The percentage required for approval stated in part d. of Article IV of the Association's Articles of Incorporation has been decreased from 67% of the members to 55% of the members.

The second sentence of Article IV (PURPOSE AND POWERS OF THE CORPORATION) of the Association's Articles of Incorporation has been amended as follows before the specified powers:

The corporation shall further have the power to:
