The Gold Coast Quilter's Guild, Inc., a Florida not for profit corporation, was administratively dissolved on September 19, 2003 for not filing the required 2003 Annual Report. The Florida Department of Agriculture & Consumer Services brought this to the Guild's attention in May 2004. At that time we proceeded to check into why this had happened.

Upon searching the files of the guild's treasurer we found the copy of the cancelled check for the 2003 \$61.25 fee and a copy of the 2003 report which had been mailed to Tallahassee on July 7, 2003. After a phone call, we discovered that there was a record of the check and the report being received, but the report was rejected for lack of some required information and a letter was sent on July 11, 2003 to that effect. The registered agent never received the July 11th letter. Consequently, we could not correct the oversight.

We have been told that to have our Not For Profit Corporate status reinstated we should 1) write a letter explaining the circumstances, 2) send information regarding the current officers and directors of the Guild, and 3) send a check in the amount of \$61.25 for the 2004 fee.

Enclosed with this letter are our check, the current officers and copies of the 2003 check and annual report. Please reinstate the Guild's not for profit corporate status.
