These Articles of Dissolution of DIDYMUS FELLOWSHIP, INC., are adopted as follows:

1. The name of the Corporation is DIDYMUS FELLOWSHIP INTERNATIONAL, INC. (Document Number N10790).
2. The Corporation does not have members.
