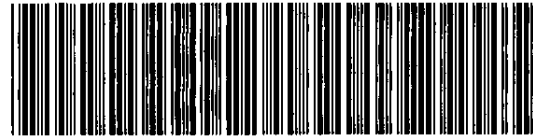

ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

This is a nonprofit corporation, organized solely for the general religious purposes pursuant to the Florida Corporations Not for Profit law set forth in Section 617 of the Florida Statutes and Section 501 (c)(3) of Internal Revenue Code of 1983, as amended. To strive for the advancement of religion and any other related or corresponding charitable purposes by the distribution of its funds for such purposes. Further, herein the term "Church" shall be used throughout these articles of incorporation for non-profit corporation. Other provisions can be found in the Bylaws.

ARTICLE IV MANNER OF ELECTION The manner in which the directors are elected and appointed:

The corporation shall hold annual elections at such time and in such manner as designated in the bylaws. The directors will be elected by the Church at the regular business meeting for the annual election. The number of directors shall be no less(4) and will be elected for a term of one year annually. Unless a director's term is terminated, each director so elected shall continue until a successor shall have been elected.
