



ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

HILLIARD HIGH SCHOOL FOUNDATION, INC.

The undersigned, President of HILLIARD HIGH SCHOOL FOUNDATION, INC., Document Number: N11000000293, acknowledges the adoption of the following Articles of Amendment to the Articles of Incorporation of HILLIARD HIGH SCHOOL FOUNDATION, INC., as unanimously approved and adopted by the members of the corporation on October 11, 2011, at 12:00 p.m., at the offices of the corporation: 960185 Gateway Blvd., Ste. 104, Fernandina Beach, Florida, 32034.

- 1. The corporation purpose of the Corporation is set forth at Article II of the Articles of Incorporation.
- 2. The following Resolution, clarifying the Corporate Purpose, was recommended by the Treasurer, passed by the directors, and approved by the members of the corporation, on October 11, 2011, in the manner prescribed by statute.

Article II, Section c, of the Articles of Incorporation is hereby created, to read as follows:

"(c) Said organization is organized exclusively for the foregoing charitable, religious, educational, or scientific purposes, and including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section(s) of any future tax code.

Notwithstanding any other provision in this document, the purposes will be limited exclusively to exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section(s) of any future federal tax code."

3. The number of memberships of the corporation outstanding at the time of such adoption was 3; and the number entitled to vote thereon was 3.
