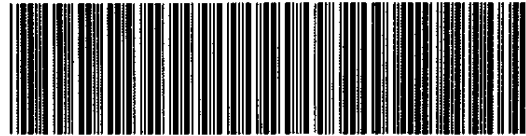

**ARTICLES OF INCORPORATION OF
WORD FOR THE WORLD CHRISTIAN FELLOWSHIP OF SOUTHWEST FLORIDA, Inc.
A FLORIDA NON-PROFIT CORPORATION**

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida non-profit corporation adopts the following articles of incorporation.

ARTICLE I

The name of the corporation shall be Word for the World Christian Fellowship of Southwest Florida, Inc. (hereinafter called the "corporation"). Said corporation is organized exclusively for religious, educational, charitable and social purposes including for such purposes the making of distributions to organizations under section 501 (c) (3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code).

ARTICLE II

The address of the initial principal office of the corporation shall be 4016 Winkler Avenue Extension #202, Fort Myers, Florida, 33916.

ARTICLE III

This corporation was specifically created as a church organization. The purposes for which this corporation is organized are: Religious, Educational, Charitable and Social. Specifically, this corporation shall act as a church and shall strive to preach and teach the Gospel of Jesus Christ, fellowship with other believers and provide Christian mercy to those who are hurting and in need.

This corporation shall also be authorized to engage in and transact any and all lawful business within and without the State of Florida or United States for which corporations not-for-profit may be incorporated under Chapter 617, Florida Statutes, as amended and supplemented.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, directors, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation in furtherance of section 501 (c) (3) purposes.

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

The method of election of as well as the qualifications and duties of the directors are stated in the bylaws of the corporation.

ARTICLE V

The Corporation shall have all of the powers conferred upon corporations organized pursuant to the provisions of Chapter 617, Florida Statutes, as amended and supplemented.

Notwithstanding any provision contained in these articles, the corporation is required to distribute its income for each taxable year at the times and in the manner as not to subject the corporation to tax under section 4942 of the Internal Revenue Code.

In addition, the corporation shall not, during any period and to the extent it is a private foundation described in section 509 of the Internal Revenue Code, (a) engage in any act of self-dealing; (b) retain any excess business holdings; (c) make any investments in a manner as to subject the corporation to tax under section 4944 of the Internal Revenue Code or (d) make any taxable expenditure as defined in section 4945 (d) of the Internal Revenue Code.

ARTICLE VI

The corporation shall be perpetual. Upon the dissolution of this non-profit corporation, after paying or making provisions for the payment of all liabilities of the corporation, the Board of Directors will distribute all assets of the corporation to any other organization or organizations of their choice that are organized exclusively for religious, educational, charitable and social purposes. Said assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future Federal tax code, or shall be distributed to the Federal government or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations as the course shall determine.


ARTICLE VII


