(1) Amendment to Article 111 by adding the required language by IRS's form 1023 is as followed: MIAMI'S CHRISTIAN FOOD AND SERVICES,INC. is organized exclusively for charitable purposes, including such purposes ,as relief for needy home bound individuals, who include the elderly, the sick, and the disabled that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

(2) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or to the federal government.
