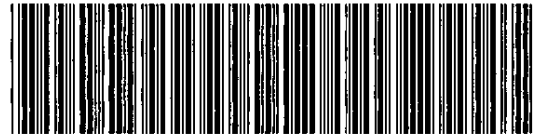

A FLORIDA CORPORATION NOT FOR PROFIT

Pursuant to the provisions of Section 617.0202, Florida Statutes, the undersigned Florida Nonprofit Corporation adopts the following Articles of Incorporation.

The undersigned, acting as incorporators of a Florida Corporation, not-for-profit under the Florida Not-For-Profit Corporation Act, Chapter 617 of the Florida Statutes, hereby adopt these following Articles of Incorporation for this Corporation:

ARTICLE I

NAME

The name of this Corporation shall be: **Somebody Cares—Hernando County, Inc.**

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be:

ARTICLE III

PURPOSE

The purpose for which this Corporation is organized is: This Corporation is organized exclusively for not-for-profit purposes.

ARTICLE IV

MANNER OF ELECTION

The manner in which the directors are elected or appointed: Each director may be appointed by the President or by a two-thirds (2/3) vote of the members of this Corporation.

ARTICLE V

INITIAL DIRECTORS/OFFICERS

The name and addresses: This Corporation shall have five (5) Directors to hold office until their successors shall have been duly elected and qualified, or until their earlier resignation, removal from office or death. The number of Directors may be either increased or decreased from time to time in accordance with the Bylaws of this Corporation but at no time shall there be less than three (3) Directors. The names and addresses of the Directors of this Corporation are as follows:

ARTICLE VIII

NO DISTRIBUTION OF PROFITS

This is a non-profit Corporation. This Corporation shall not have any power to issue certificates of stock or declare dividends, and no part of its net earnings shall inure to the benefit of any member, director or individual.

ARTICLE IX

PROHIBITION AGAINST POLITICAL ACTIVITIES

No substantial part of the activities of this Corporation shall be devoted to the promulgation of propaganda, or otherwise attempting to influence legislation, and this Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for political office.

ARTICLE X

DISTRIBUTION OF ASSETS UPON DISSOLUTION

In the event of the dissolution of this Corporation, or in the event it shall cease to carry out the objectives and purposes herein set forth, all the business, property and assets of this Corporation shall go and be distributed to such non-profit corporation(s) as may be selected by the Board of Directors of this Corporation so that the business, properties and assets of this Corporation shall then be used for, and devoted to, non-profit purposes. In the event of the dissolution of this Corporation, or upon its ceasing to carry out the object and purposes set forth, the property and assets then owned by this Corporation shall be devoted exclusively to non-profit purposes.

ARTICLE XI

VOTERS ONLY

FIRST:


Only the President and Board of Directors may vote on these Articles of Incorporation.


SECOND:

IN WITNESS WHEREFORE, the undersigned have executed and adopted these Articles of Incorporation this 13 day of JANUARY 2011.

THIRD:

There is no member or members entitled to vote on these Articles of Incorporation. The President and Chairman of the Board adopted these Articles of Incorporation.





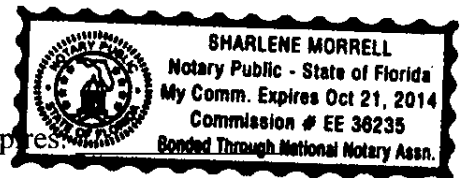
