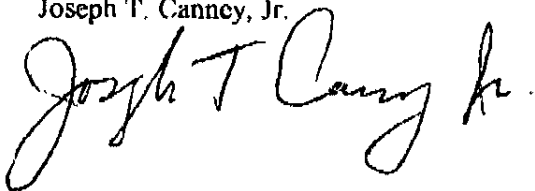

ARTICLES OF INCORPORATION
In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Dream Waves America Incorporated

ARTICLE II PRINCIPAL OFFICE

Principal street address: 1933 SW Palm City Rd. B, Stuart, FL 34994

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: Dream Waves America Incorporated is organized exclusively for charitable purposes under section 501(C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code to provide free nautical recreational services including fresh air, sunshine, sea breezes, and personal attention, as thanks to all injured service men and women for their selfless dedication to their country, and provide the same to others with serious disabilities and their care-giving families.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected and appointed: *Election of Directors.* The directors shall be elected by the vote of the directors then in office; and those persons who receive the highest number of votes at a meeting at which a quorum is present shall be deemed to have been elected. If any director so demands, the election of directors shall be by ballot. The present intent of the Board of Directors, which is non-binding, is that the persons holding the following positions, from time to time, shall be elected to the Board of Directors as ex officio members: *[chairperson of the Chamber of Commerce; chairperson of the Martin County Commission; representative from the United Way or other major community charity. These ex officio members may be designated voting or non-voting.]*
