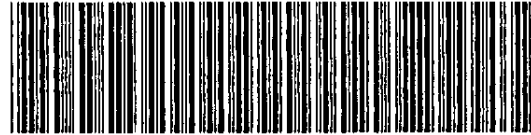

b) No part of the net earnings of the organization shall inure to the benefit of, or to be distributable to its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services in the purpose clause hereof. No substantial part of the activities of the organization shall be the carryon of propaganda, or otherwise attempting to influence legislation.

**ARTICLE VIII (cont.)**

The organization shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate running for public office. Notwithstanding, any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)3 of the Internal Revenue Code, or (b) by an organization that contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

c) Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code or any future tax code, or shall be distributed to the federal government or to a State or local government for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Common Pleas of the County in which the principal office of the organization then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
