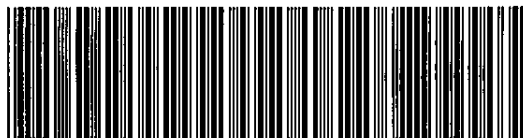

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

Article I

The name of the corporation is:

Samaritan Community Outreach Center, Inc

Article II

Article III

The period of duration of the corporation is perpetual.

Article IV

The specific purpose for which this corporation is organized is:

Samaritan Community Outreach Center, Inc extends our assistance to help the community as an entity of hope, helping to bring an economic balance to the overwhelming stressful anxieties of those in need of much help with everyday common needs. The Corporation purpose is to establish 501 © (3) status under the laws of the state of Florida internal revenue code. The object and purpose to be transacted and carried on are to promote the general social welfare of the community and for that purpose:

1. To promote the economic, social, educational, cultural and welfare of the migrant, seasonal farm workers, indigent and other rural poor people in and about, but not limited to Okeechobee County, Florida.
2. To administer to the economic and social needs of the elderly.

3. To acquire available grants that will assist in the endeavor of rendering diverse services for farm workers and other poor without regard to race, color, creed, national origin, age, sex, marital status, or physical or mental handicap.
4. Services rendered by the Samaritan Community Outreach Center, Inc. are free food pantry, HIV/AIDS testing and education, health screening such as blood pressure checks and blood sugar monitoring checks, etc. As it pertains to none internal medical diagnosis, on-line services aiding those of the community the opportunity to services needed and available to them by the government. Thrift store offering clothes, household items etc.
5. To do all things necessary and appropriate for the carrying out and exercising the foregoing purposes and powers.
6. No part of the net earnings of the Corporation shall inure to the benefit of any member, trustee, officer of the Corporation, or any private individual, except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes, and no member, trustee, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the Corporation shall not participate in or intervene in, including the publication or distribution of statements, any political campaign on behalf of any candidate for public office.

Article V

The manner in which the directors are elected or appointed is:

The qualifications for members and the manner of their admissions shall be regulated by the by-laws.

Article VI

In the event of dissolution of this corporation or in the event it shall cease to carry out the objects and purposes herein set forth, all business, property and assets of the corporation shall go and be distributed to one or more exempt purposes within the meaning of 501 (c) (3) of the Internal Revenue code, or corresponding

section of any future federal tax code or to federal, state or local government for public purpose. In no event shall any of the assets or property, in the event of dissolution thereof, go or be distributed to members, either for reimbursement of any sum subscribed, donated, or contributed by such members, or for any other purpose provided that nothing herein shall prohibit the corporation from paying its just debts.
