Article I

Article IV

The specific purpose for which this corporation is organized is:

Samaritan Community Outreach Center, Inc extends our assistance to help the community as an entity of hope, helping to bring an economic balance to the overwhelming stressful anxieties of those in need of much help with everyday common needs. The Corporation purpose is to establish 501 © (3) status under the laws of the state of Florida internal revenue code. The object and purpose to be transacted and carried on are to promote the general social welfare of the community and for that purpose:

- To promote the economic, social, educational, cultural and welfare of the migrant, seasonal farm workers, indigent and other rural poor people in and about, but not limited to Okeechobee County, Florida.
- 2. To administer to the economic and social needs of the elderly.

- 3. To acquire available grants that will assist in the endeavor of rendering diverse services for farm workers and other poor without regard to race, color, creed, national origin, age, sex, marital status, or physical or mental handicap.
