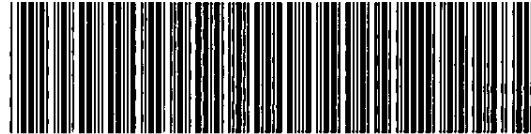

Amend Article III: DeLeon Springs Community Association, Inc. is organized exclusively
for charitable, religious, educational and scientific purposes, including, for such purposes,
the making of distributions to organizations that qualify as exempt organizations under
section 501(c)(3) of the Internal Revenue Code or corresponding section of any future
federal tax code.

Amend Article IV: by majority vote of the members of the DeLeon Springs Community
Association, Inc. at the annual meeting.

Add Article VI: Upon dissolution of the DeLeon Springs Community Association, Inc. assets
shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3)
of the Internal Revenue Code, or corresponding section of any future federal tax code, or
shall be distributed to the federal government or to a state or local government for a public
purpose. Any such assets not disposed of shall be disposed of by a Court of Competent
Jurisdiction of Volusia County, exclusively for such purposes or to such organization or
organizations as said Court shall determine which are organized and operated exclusively
for such purposes.
