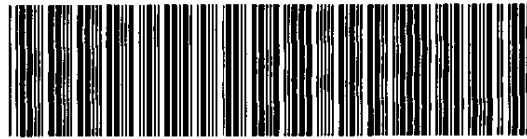

Articles of Amendment

Articles of Incorporation

Article I of the Articles of Incorporation of TEAM HOUSE, INC., a Florida not for profit corporation, was amended by the corporation's board of directors on April 29th, 2011. The corporation is filing these articles of amendment to articles of incorporation pursuant to F.S. 607.0602.

1. **The name of the corporation is TEAM HOUSE, INC.**
2. **Article III of the Articles of Incorporation of TEAM HOUSE, INC. was amended to read as follows:**

"The general purposes for which this corporation is organized are exclusively charitable, scientific, literary, and educational within the meaning of Section 501(c)(19) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States tax code. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on

- (a) by an organization exempt from Federal income tax under Section 501(c)(3) and or 501(c)(2) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States tax code, or
- (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding provision of any future United States tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

The corporation shall further function and operate as a Florida not for Profit Corporation specifically for the following purposes and with the following exclusive purpose:

To hold title to property, collecting income therefrom, and turning over the entire amount thereof, less expenses, to T.G.B.A, Inc., A Florida not for Profit Corporation which is a 501(c)(19) tax exempt organization."


3. Article XI of the Articles of Incorporation of TEAM HOUSE, INC. was amended to read as follows:

"The only member of the organization will be T.G.B.A., Inc., a Florida not for Profit Corporation, with the exception of the Officers and Board of Directors."

4. The foregoing amendment to the Articles of Incorporation was duly adopted by the board of directors on April 29th, 2011.

5. The amendment was approved by the members. The number of votes cast for the amendment was sufficient for approval.

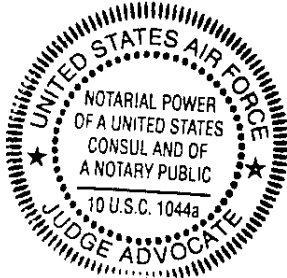
