ARTICLE III Purpose -

1 M

No part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under section 501 (c)(3) of the Internal Revenue Code, or corresponding provisions of any future United States Internal Revenue Code.

This corporation shall provide basic christian doctrines in its program and not promote any denomination or organization. No student will be denied admission due to race, color or creed or national origin.

Specifically this corporation is formed to create, organize and implement educational activities as a christian school under the laws of the state of Florida education program:

- (a) create an environment for student learning
- (b) provide opportunities for all students to maximize and expand their learning experiences as well as identify and address any deficiencies
- (c) promote the use of different and innovative learning methods
 - (d) enhance student motivation by increasing self-esteem

ARTICLE VIII DISSOLUTION -

Upon dissolution of the corporation, its assets remaining after payment of, or provision for payment ofall debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable or educational purposes and which has established its tax exempt status under section 501 (c)(3) of the Internal Revenue Code.
