Attachment to Articles of Incorporation of Techie Kids Programs, Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: Our mission is to inspire kids, through technology and media, to discover their own unique gifts and abilities to create brighter futures for themselves in order to make a difference in their lives and the communities in which they live. This mission includes laying a foundation to help kids understand the power technology and media possess in life's successes by offering the basics from a creative and maintenance standpoint and offering various tech and media workshops, collecting and reconditioning used computer equipment, identifying qualified recipients and placing the appropriate equipment with them solely for their use at no charge.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.
