ARTICLES OF INCORPORATION

OF

BEREAN CHRISTIAN COLLEGE AND SEMINARY, INC.

We the undersigned, with other persons being desirous of forming a corporation not for profit under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I - NAME

The name of this corporation is: Berean Christian College and Seminary, Inc.

ARTICLE II - PURPOSE

The general nature of the objects and purposes of this corporation shall be:

Section 1. To do any and all lawful acts and things which may be necessary, useful, suitable, or proper for the instruction and furtherance of evangelical Christian values; and to do any and all other activities permitted by Florida Statutes to be performed by a corporation not for profit.

Section 2. No part of the net earnings of the corporation shall insure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered by pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Section 1 above. No substantial part of the

activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE III - TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE IV - MEMBERSHIP

Members of this corporation shall be qualified and admitted as provided in its By-laws.

ARTICLE V - BOARD MEMBERS
