ARTICLES OF INCORPORATION OF Save A Sole, Inc

A Florida "Not for Profit" Corporation In compliance with Chapter 617, F.S., (Not for Profit) SECRETARY OF STATIONS

The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

- I. NAME OF CORPORATION: The name of the corporation is Save A Sole, Inc.
- II. PRINCIPAL OFFICE: The principal office of the corporation is located at 12420 NW 15th Street, Unit 307, Sunrise, Fl 33323.
- III. MAILING ADDRESS: The mailing address of the corporation is 12420 NW 15Th Street, Unit 307, Sunrise, FI 33323.
- **IV. REGISTERED AGENT:** The name of the registered agent of the corporation is Francois Chebat. The address of this registered agent is 12420 NW 15Th Street, Unit 307, Sunrise, FI 33323.
- **V. DURATION/MEMBERSHIP:** The period of duration is perpetual. The qualification for members, if any, and the manner of their admission shall be regulated by the bylaws.
- VI. BOARD OF DIRECTORS: The method of selection of the Board of Directors and number of directors shall be stated in the bylaws.
- **VII. INCORPORATORS:** The name and address of the incorporator is: Francois Chebat, 12420 NW 15Th Street, Unit 307, Sunrise, FI 33323.
- VIII. CORPORATE PURPOSES: The purposes for which this corporation is formed are exclusively for charitable, religious, educational and scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law."
- IX. LIMITATIONS: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article VIII hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this

corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

- X. DISSOLUTION: Upon winding up and dissolution of the Corporation, the assets of the Corporation, remaining after payment of all debts and liabilities, shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
- XI. INDEMNIFICATION Any person (and the heirs, executors and administrators of such person) made or threatened to be made a party to any action, suit or proceeding by reason of the fact that he/she is or was a Director or Officer of the Corporation shall be indemnified by the Corporation against any and all liability and the reasonable expenses, including attorney's fees and disbursements, incurred by him/her (or by his/her heirs, executors or administrators) in connection with the defense or settlement of such action, suit or proceeding, or in connection with any appearance therein, except in relation to matters as to which it shall be adjudged in such action, suit or proceeding that such Director or Officer is liable for negligence or misconduct in the performance of his duties. Such right of indemnification shall not be deemed exclusive of any other rights to which such Director or Officer (or such heirs, executors of administrators) may be entitled apart from this Article.
