

Articles of Amendment to the Articles of Incorporation of Foundation for Innovation,
Inc., a Florida Not-for Profit Corporation.
(in compliance with Chapter 617 F.S.,(Not for Profit)

ARTICLE III. PURPOSE

The purpose of the corporation shall be: to fund innovative solutions in treating abused, neglected and special need kids and their families, with all distributions to be made in accordance with the meaning of the relevant section 501(c)3 of the Internal Revenue Code.

ARTICLE IX. MANNER OF DISTRIBUTIONS

The corporation will distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX. PROHIBITION ON SELF DEALING

The corporation will not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX. NON-RETENTION OF EXCESS HOLDINGS

The corporation will not retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX. INVESTMENT LIMITATIONS

The corporation will not make any investments in a manner as to subject it to tax under section 4944 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX. LIMITATION ON EXPENDITURES

The corporation will not make any taxable expenditures as defined in section 4945(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
