### MATTHEW 25:40 MINISTRIES, INC. AMENDED ARTICLES OF INCORPORATION

#### ARTICLE III - PURPOSE:

The specific purpose for which this corporation was organized is:

Matthew 25:40 Ministries, Inc. is organized exclusively for religious and charitable purposes for relief to the poor, the needy and the underprivileged and to advance Christianity amongst the poor, needy and underprivileged within the meaning of section 501(c)(3) of the Internal Revenue Code, and, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future United States Internal Revenue law.

Upon the winding up and dissolution of the Matthew 25:40 Ministries, Inc., and after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the Federal Government or to a state or local government, for a public purpose.

No part of the net earnings of the Matthew 25:40 Ministries, Inc. shall inure to the benefit of, or be distributable to, any of its members, trustees, officers or other private persons, except that the corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes.

No substantial part of the activities of the Matthew 25:40 Ministries, Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the Matthew 25:40 Ministries, Inc. shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
