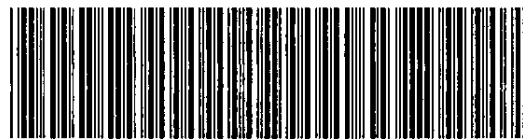

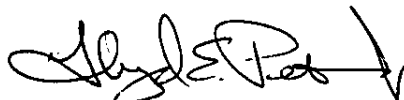

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a Not for Profit business corporation.

ARTICLE I - NAME

The name of the Not for Profit Corporation is: SUWANNEE RIVER CAMPFIRE MINISTRIES, INC.

ARTICLE II – PRINCIPAL OFFICE

ARTICLE III - PURPOSE

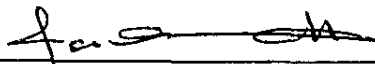

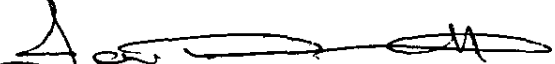

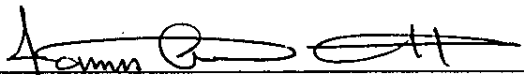
