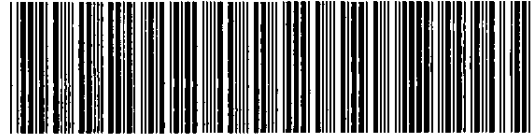

ARTICLES OF INCORPORATION

I, the undersigned natural person of the age of eighteen or more, acting as Incorporator of a corporation, do hereby form a Non-Profit corporation under the general laws of the State of Florida.

**FIRST:** The name of the corporation is Links To The Future, Incorporated.

**SECOND:** The principal place of business and mailing address of the corporation is:  
41 Bunker Hill Drive, Palm Coast, Florida 32137.

**THIRD:** The purposes for which the corporation is organized are : to help prepare minority and disadvantaged youths for successful living and successful careers in golf by introducing them to the skills, disciplines, rules and etiquette of the game of golf at its highest professional level ; and to give training, instruction, and preparation to said youth in all phases of the game of golf, including, affording them competitive opportunities at all appropriate levels .

To sponsor tournaments, workshops, clinics, camps, schools and programs centered on the game of golf for said minority and disadvantaged youths and their constituents; and to sponsor and / or underwrite professional and amateur golfers who in turn devote a substantial portion of their time and / or earnings to the corporation .

To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attainment of the above purposes, either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, institutions, foundations, or governmental bureaus, departments, or agencies.

Said corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article THIRD hereof. No substantial part of the activities of the corporation shall be the carrying on the propaganda, or otherwise attempting to influence legislation,

and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future) United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law)

**FOURTH:** The directors/officers shall be elected or appointed as provided in the Bylaws.

**FIFTH:** The number of directors/officers constituting the initial Board of Directors is three and the names and addresses, including street and numbers of the persons who are to serve as the initial directors until the first annual meeting or until their successors be elected and qualified are:
