ARTICLE I

NAME

The name of this Corporation shall be **MT. PLEASANT MINISTRIES OF CAPPS, INCORPORATED.**

ARTICLE II

ENABLING LAW

This Corporation is organized in accordance with the corporation's **not-for-profit** law of the State of Florida, as set forth in Part 1 or Chapter 617 of the Florida Statutes.

ARTICLE III

PRINCIPAL PLACE OF BUSINESS

The principal place of business of this Corporation shall be: **9472 South Jefferson Street, U. S. Highway 19 South, Capps, Florida;** the mailing address is **P.O Box 805, Monticello, Florida 32344.**

ARTICLE IV

PURPOSE

The purpose for which this Corporation is organized is to provide a **spiritual anointing** and a **ministry of reconciliation** that will reflect and continue the messianic mission of Jesus Christ for the poor, the brokenhearted, and the heavy laden throughout needed areas of our and adjoining communities.

1. This Corporation shall have the power to receive grants and gifts of real property and/or personal property and/or cash to accomplish the above purpose.
2. Notwithstanding any other provision of these Articles, the Corporation shall not

carry on any other activities not permitted to be carried on (1) by a Christian corporation that is exempted from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (2) by a Christian corporation any contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

3. This Corporation is organized with exclusive operation for spiritual, cultural, educational, and charitable purposes in consistent accordance with Section 501(c)(3) of the Internal Revenue Code.
4. The organization and operation of this Corporation shall be on a not-for-profit basis for any net earnings for members, officers, and directors except where salaried or wage-earner employees have been declared by the general membership.
5. This Corporation has been organized on a spiritual basis and shall not consist of carrying on political propaganda, or make an attempt to influence legislation in an overt or covert manner or even participate in any political campaign on behalf of, or in opposition to, any candidate for public office. (This would include publishing or distributing any statement to benefit or oppose any public official.)

ARTICLE V

BOARD OF DIRECTORS

Section 1. Number. There shall be a Board of Directors consisting of not less than three (3) and not more than fifteen (15) persons who shall be of legal age.

Section 2. Manner of Election or Appointments. The authorized number, qualifications, and manner of election/appointment of members of the Board of Directors to this Corporation shall be as set forth in the By-Laws of this Corporation.

ARTICLE VI
