ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation not for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**Article I
NAME**

The name of the corporation shall be: WCMF Foundation, Inc.

**Article II
PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal place of business and the mailing address of this corporation shall be: 4190 Belfort Road, Ste. 450, Jacksonville FL 32216.

**Article III
REGISTERED OFFICE AND AGENT**

The address of the corporation's initial registered office and the name of its initial registered agent is Wayne Conner, 4190 Belfort Road, Ste. 450, Jacksonville, FL 32216.

**Article IV
INCORPORATORS**

The name and street address of the incorporator to the corporation is: Wayne Conner, 4190 Belfort Road, Ste. 450, Jacksonville, FL 32216.

**Article V
DIRECTORS**

The number of the initial Board of Directors shall be Two (2). The number of Directors may be increased or decreased from time to time by bylaws of the corporation. The names and residences of the Directors for the first years and until their successors shall have been elected and shall have accepted office are as follows:

The Board of Directors is hereby specifically authorized to make provision for reasonable compensation to its members for their services as directors, and to fix the basis and conditions upon which such compensation shall be paid. Any director of the corporation may also serve the corporation in any other capacity and receive compensation thereof in any form.

In furtherance, and not in limitation of the powers conferred by statute, the Board of Directors is expressly authorized to:

A. Adopt the initial Bylaws of the corporation. Further the Bylaws shall be adopted, altered, amended or repealed from time to time by either the shareholders or the Board of Directors, but the Board of Directors shall not alter, amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to amendment or repeal by the directors.

B. In general, to manage the affairs of said corporation in such a manner as shall be deemed advisable by said Board.

Article VI

PURPOSE

The purpose for which the corporation is organized is as follows: To bring restoration to families by providing youth relevant, inspiring, interactive and cutting edge program that will help develop and improve their character while providing non-traditional outlets for them to express their creativity, cultivate their self-esteem and self-worth and build a sense of accomplishments and accountability for their choices. At the end of the day the program will inspire a renewed passion for Life within the youth, and cause them to make quality choices that will prevent at-risk behavior, and cultivate better "future family" structures.

WCMI Foundation, Inc., will focus on the following youth empowerment initiatives:

- **Torchbearers:** A mentorship program that impact and build youngsters and also provides support systems involving job training skills, school visits/after school programs, goal casements and life skills.
- **Link-Up:** This is an initiative to provide preventive measures that address negative attention seeking behaviors, and in other cases provide rehabilitation measures.
- **Souljahz Inc.:** Youngsters enlisted and equipped with an assignment to impact their generation.
- **Think - Get Your Mind Right:** Motivational speakers in area schools discussing the importance of education through nontraditional settings.
- **Young World:** Evangelical outreaches, involving radio and televangelism.
- **Project Positive Vibe:** A campaign in an effort to clean up America's music and its young minds providing exciting, innovative and relative mainstream media alternatives.
- **P.O.W.E.R. Kids:** an initiative designed to fight the battle against childhood obesity through project concept, program development and marketing and communications.

- **Make A Move:** A campaign which connects the comprehensive strategies of political, business and spiritual leaders with the grassroots programs and organizations that are currently investing in our youth.

Article VII POWERS

The Corporation shall have all of the common law and statutory powers of a corporation not for profit pursuant to the laws of the State of Florida that are not in conflict with the terms of these Articles; provided, however, that notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax pursuant to Section 501(c)(3) of the Internal Revenue Code, as amended, or the corresponding provision of any future United States Internal Revenue Law.


Article VIII LIABILITY

The Board of Directors of this Corporation is hereby specifically authorized to make provision of indemnification of directors, officers, employees and agents to the full extent permitted by law.

Article IX TERM

Corporate existence shall commence upon filing these Articles of Incorporation with the Secretary of State and the term of the Corporation shall be perpetual.
