Attachment to Articles of Incorporation of Focus Minds INC.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To promote literacy to all children. To teach young children to read which will help them to develop their language skills. It also helps them learn to listen.
