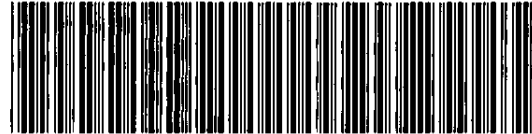

### 3. PURPOSE

The purpose for which the corporation is organized is to promulgate the Gospel of Jesus through radio, television, and internet broadcasts; additionally through publications, seminars, meetings, and conferences; to evangelize to the lost; to minister help & encouragement to the needy; to train and disciple adherents, to engage in any lawful activity for which non-profit corporations may be organized under the general corporate Law of Florida.

Furthermore, the said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distribution to organizations qualifying as an exempt organization from Federal income tax under section 501(c)(3) of the Internal Revenue code, or corresponding section of any future Federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c) 3 of the future United States Internal Revenue Law, (see attached sheets for continued amendments)

**9. DISSOLUTION:**

**Upon the dissolution of the assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets no disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.**


