***ARTICLES OF INCORPORATION***

(A Florida Corporation Not For Profit)

These Articles of Incorporation are executed by the undersigned for the purpose of forming a Florida not for profit corporation under the Florida Not For Profit Corporation Act, Chapter 617 of the Florida Statutes.

**ARTICLE I**

**Name**

The name of the corporation is SOUTH SHORE COALITION FOR MENTAL HEALTH & AGING, INC.

**ARTICLE II**

**Initial Principal Office**

The street address and the mailing address of the corporation is Sun Towers, 101 Trinity Lakes Drive, Room No. 254, Sun City Center, Florida 33573.

### **ARTICLE III**

#### **Purpose**

SOUTH SHORE COALITION OF MENTAL HEALTH & AGING, INC., is organized exclusively for charitable, cultural, educational, health, scientific and public safety purposes. Subject to the foregoing, the corporation is an organization for senior adults living in the South Shore area of Hillsborough County, Florida, dedicated to promoting healthy aging and facilitating optimum mental health. It seeks (1) to promote healthy aging through screening for dementia, depression and other related disorders and providing support groups for persons who have difficulty coping with life changes brought on by the aging process, (2) to facilitate optimum mental health through public health education and research and providing information, tools, resources and other support designed to eliminate the stigma associated with mental health care, and (3) to plan and execute fundraising programs for providing healthy aging and mental health services.

### **ARTICLE IV**

#### **Directors**

The manner of electing Directors shall be provided in the By-Laws. The number of Directors shall be fixed from time to time as provided in the By-Laws, but shall not be less than three (3). The name and address of each member of the initial Board of Directors is set forth below:

## **ARTICLE V**

### **Members**

The manner of determining the Members of the corporation shall be provided in the By-Laws.

## **ARTICLE VI**

### **Prohibition on Issuance of Stock, Payment of Dividends and Certain Activities**

This corporation shall not have or issue shares of stock and shall not pay dividends. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry

on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## **ARTICLE VII**

### **Dissolution**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes. No Director, Member, Officer or private individual shall be entitled to share in the distribution of any of the corporate assets.

## **ARTICLE VIII**

### **Initial Registered Office and Initial Registered Agent**

The initial registered office of the corporation is located at Sun Towers, 101 Trinity Lakes Drive, Room 254, Sun City Center, Florida 33573. The initial registered agent of the corporation, who is located at such address, is Kenneth D. Barringer, Ph.D.
