Articles of Incorporation of

Hrtstrings, Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue. Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: The Corporation is organized exclusively for charitable and supportive outreach purposes. The corporation is a non-profit organization formed by a group of mother's who have endured the loss of child/children, reaching out to others who are on the same journey proving charitable donations and supportive outreach. To this end, the corporation shall at all times be operated exclusively for charitable and supportive outreach purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contributions of otherwise, shall be devoted to said purposes
