Articles of Incorporation of Cultural Crete USA, Inc

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows; ADVANCING AND PROMOTING THE CULTURE, MUSIC & TRADITIONS OF THE ISLAND OF CRETE, VIA EDUCATIONAL SEMINARS, AWARDING OF SCHOLARSHIPS FOR UNIVERSITY STUDENTS & ORGANIZING OF MUSIC & CULTURAL EVENTS IN THE UNITED STATES.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.
