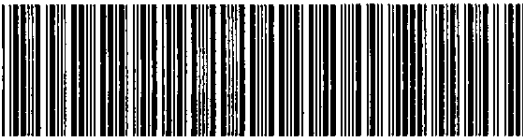

Notice is hereby given that the undersigned incorporator, being of full age, has associated themselves together for the purpose of forming a corporation not for profit, without capital stock, under the provisions of Chapter 617, Florida Statutes, and we do hereby make, subscribe, acknowledge and file these Articles of Incorporation.

ARTICLE I:
NAME OF CORPORATION

The name of the corporation is: LAKE COUNTY TENNIS ASSOCIATION, Inc.

ARTICLE II:
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III:
CORPORATE PURPOSE

This corporation is organized exclusively for all purposes for which a corporation, not-for-profit, may be formed under the laws of the State of Florida; specifically excluded from the corporation's purposes are any pecuniary profit or financial gain. The purpose of the corporation is: to promote, encourage and foster the development and growth of the sport of tennis at the amateur level for junior, adult, and senior players in the Lake and West Orange Counties.

ARTICLE IV:
MEMBERSHIP

Membership shall be open to any person interested in furthering the purposes of the corporation, as set forth in these articles, and who qualifies for membership in accordance with the bylaws of the corporation, as may be adopted or amended from time to time by the Officers and Directors of the corporation. The membership shall annually elect the officers and Directors of the corporation, by the procedures specified in the bylaws of the corporation. The membership shall have such additional voting rights as shall, from time to time, be set forth in the bylaws of the corporation.

ARTICLE V:
MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

1. The initial directors will be appointed by the incorporator.
2. Other directors shall be elected by the members as provided by the bylaws of the corporation at its annual meeting.
3. The Board of Directors will consist of at least five directors.
