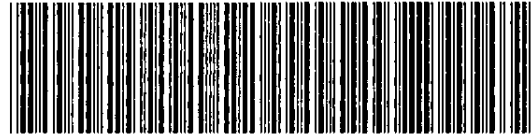



ARTICLES OF INCORPORATION OF

I.M.U.A.S. FOUNDATION, INC.

(In compliance with Chapter 617, F. S.)

NOT FOR PROFIT FOUNDATION

ARTICLE I - NAME

The name of this Corporation is:

IMUAS FOUNDATION, INC..

ARTICLE II - DURATION

This non profit corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State. This corporation (FOUNDATION) is being formed as a 501(c) (3) tax-exempt organization, as the corporation's assets are dedicated to tax-exempt purposes.

ARTICLE III - PRINCIPAL OFFICE AND REGISTERED AGENT

The principal place of business, street address, & mailing address of the initial principal and registered office of this corporation is 4000 Towerside Terrace # 407, Miami, FL 33138, and the name of the initial registered agent of this corporation at that address is, Dr. Walter B. Lebowitz

ARTICLE IV - PURPOSE

ARTICLE V - DIRECTORS - MANNER OF ELECTION

The manner in which the directors are elected or appointed is that the majority of the initial Three (3) directors shall have the authority by majority vote of existing directors, to appoint any other directors that they believe will be of assistance to this corporation in fulfilling its purpose.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

This corporation shall have Three (3), Directors constituting the initial Board of Directors. The number of Directors may be either increased or decreased from time to time by the By Laws. This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
